# V. Declaration of the Bidder

The Bidder declares that:

- a) it has made itself acquainted with the Regulations and the Tendering Manual issued by the Compensation Administrator pursuant to § 4 sect. 4 o the Regulations and that it understands and agrees to the provisions of the same;
- b) there are no legal or actual obstacles that would prevent the Bidder from submitting a bid and concluding a valid sales contract for an Asset;
- c) if the bid submitted by the Bidder in the Tender is chosen, the Bidder shall pay to the bank account specified by the Compensation Administrator the total purchase price of the Asset three days prior to conclusion of: (i) the conditional sales contract for an Asset or submits a bank guarantee the beneficiary of which is Stocznia Gdynia SA and the contents of which (in particular the conditions of releasing the amount guaranteed to the beneficiary) are clearly accepted by the Compensation Administrator in writing (pursuant to § 10 sect. 2 and 3 of the Regulations), (ii) sales contract for an Asset (if conditional contract is not necessary), which means that the total purchase price of the Asset is transfer red to the relevant bank account of Stocznia Gdynia SA. prior to the effective date of the contract. The total purchase price shall be paid without any deductions (art. 498 and the following ones of the Civil Code);
- accepts unconditionally the validity period of the Bid to be submitted in the Tender by December 31<sup>st</sup>, 2009;
- e) the Bidder's conclusion of a sales contract as a result of the Tender does not require a consent of the body of the Bidder or such consent has been given;
- f) accepts the draft sales contracts (conditional sales contracts) prepared by the Compensation Administrator to be published at the web page of the Compensation Administrator and the web page of Stocznia Gdynia SA;
- g) in the case of cancellation of the tender by the Compensation Administrator, the Bidder shall not lay any claims for damages on account of any losses arising from the cancellation of the Tender and shall not demand that any expenditures made in connection with participation in the tender be reimbursed;
- h) it accepts the fact that the Estimated Price being at the same time the Starting price in individual tenders is a net price, i.e. exclusive of the tax on goods and services. If the sale of an Asset is subject to the tax on goods and services, the purchase price of the Asset shall be increased by the due tax on goods and services and if it is required to pay the tax on civil-law activities, the Bidder shall be obliged to pay the tax. The Bidder shall also incur any and all costs related to conclusion of sales contracts for the Asset (conditional / disposition contracts), including in particular costs of notarial fees, costs of entries to land and mortgage registers;
- it accepts the fact that messages sent by electronic mail by the Compensation Administrator are considered as delivered effectively to the Bidders on the day they are received by the Bidder's electronic mail server, irrespective of the tome of their actual receipt. If the Bidder mentioned two or more electronic mail addresses in the Registration Declaration, the message

sent by the Compensation Administrator to one of the addresses shall be effective, whereas the Compensation Administrator shall firstly send messages to the electronic mail addresses of persons authorized to represent the Bidder (table no. 2);

- j) it confirms that it is aware that this Registration declaration along with the appendices referred to in § 5 sect. 4 and sect. 5 of the Regulations prepared in Polish or submitted along with certified translations into Polish, should be submitted to the Office of the Compensation Administrator at the seat of Stocznia Gdynia SA in ul. Czechosłowacka 3, 81-969 Gdynia, in the period specified in the announcement of the Tender. The Bidder understands that the date of submission of documents shall be considered the date of receipt of the shipment by the Office of the Compensation Administrator;
- k) it consents for the Compensation Administrator "Bud-Bank Leasing" Sp. z o.o. with its seat in Warsaw – to process personal data of the Bidder for the purpose and to the extent necessary to render it possible for the Bidder to participate in the Tender and conclude a valid purchase contract for an asset;
- 1) when submitting its bid in the tendering procedure, the Bidder acts in good faith and intends to purchase an asset offered in the Tender;
- m) the data provided by the Bidder in the Registration Declaration is complete and true.
