- 5. The tender proceedings were specified by the President of the Industrial Development Agency S.A. by resolution as of the 12th of March 2009 approving the By-law for an open tender and an auction (hereinafter referred to as the By-law). The By-law is available at the seat of Stocznia Gdynia S.A. and at the website of Stocznia Gdynia S.A. www.stocznia.gdynia.pl.
- 6. Detailed conditions for participation in the tender were specified in § 5 of the By-law. - 7. The evaluation price of property components offered for sale in the scope of each tender, quoted by the Compensation Administrator is an opening bid price in the meaning of § 1 letter j. of the By-law.
- 8. First stage of tenders no 32-36 shall take place on the 29th of April 2009. Tender no 37 which shall take place in the mode of a single stage, simplified tender, according to § 9 of the By-law shall take place on the 28th of April 2009.
- 9. In case a purchaser of property components is not selected in any of the two stages of tenders no 32 -36 or in a single stage tender no 37, due to reasons specified in § 10 section 1 of the By-law, including in particular in the case of tender invalidation or its realization

failure, the Compensation Administrator shall sale the asset components of Stocznia Gdynia S.A. by means of an auction. The auction shall take place in the period of 3 days since tender invalidation or its realization failure has been announced. The condition for participation in the auction is registration and payment of a deposit in the period of three days since tender invalidation or its realization failure has been announced, by entities which have not previously paid the deposit.

- 10. Payment of the sale price can not be realized even partially by realization of rights to execute any deductions (in the meaning of art. 498 and the following of the Civil Code).
- 11. The tender participant whose bid has been ultimately selected in the tender bears all costs connected with signing of the agreement.
